Introduction and objectives of work

This information and its presentation are the sole responsibility of the management of Amazon. Our sole responsibility was to provide independent assurance on the accuracy of the Subject Matter.

Scope of work

The scope of our work was limited to assurance over the percent renewable energy for the period January 1, 2021 to December 31, 2021 (the 'Subject Matter').

Data and information supporting the percent renewable energy were mostly historical in nature and in some cases estimated.

Our assurance does not extend to any other information included in the Amazon Renewable Energy Methodology.

- Worldwide

Reporting Criteria

The Subject Matter needs to be read and understood together with the Amazon Renewable Energy Methodology.

Limitations and Exclusions

Excluded from the scope of our work is any assurance of information relating to:

Activities outside the defined assurance period;

This limited assurance engagement relies on a risk based selected sample of sustainability data and the associated limitations that this entails. The reliability of the reported data is dependent on the accuracy of metering and other production measurement arrangements employed at site level, not addressed as part of this assurance. This independent assurance engagement and associated statement should not be relied upon to detect all errors, omissions or misstatements that may exist.

Responsibilities

This preparation and presentation of the Subject Matter are the sole responsibility of the management of Amazon.

Apex was not involved in the drafting of the of the Reporting Criteria. Our responsibilities were

- obtain limited assurance about whether the Subject Matter has been prepared in accordance with the Reporting Criteria;
- form an independent conclusion based on the assurance procedures performed and evidence obtained; and
- report our conclusions to the Stakeholders of Amazon.

Assessment Standards

 We performed our work in accordance with Apex's standard procedures and guidelines for external Assurance of Sustainability Reports and International Standard on Assurance Engagements (ISAE) 3000 Revised, Assurance Engagements Other than Audits or Reviews of Historical Financial Information (effective for assurance reports dated on or after Dec. 15, 2015), issued by the International Auditing and Assurance Standards Board. A materiality threshold of ±5percent was set for the assurance process.

Summary of Work Performed

As part of our independent verification, our work included:

- 1. Assessing the appropriateness of the Reporting Criteria for the Subject Matter;
- 2. Conducting interviews with relevant personnel of Amazon;
- Reviewing the data collection and consolidation processes used to compile the Subject Matter, including assessing assumptions made, the data scope and reporting boundaries;
- 4. Reviewing documentary evidence provided by Amazon;
- 5. Agreeing a selection of the Subject Matter to the corresponding source documentation; and
- 6. Reviewing Amazon systems for quantitative data aggregation and analysis.

Reported Data

The percent renewable energy (electricity) consumed as reported by Amazon within the defined boundaries was 85%.

Conclusion

On the basis of our methodology and the activities described above:

- Nothing has come to our attention to indicate that the Subject Matter has not been properly prepared, in all material respects, in accordance with the Reporting Criteria; and
- It is our opinion that Amazon has established appropriate systems for the collection, aggregation and analysis of quantitative data.
